Headed by newly recruited Clinical Assistant Prof. of Law Hannah Garry, the clinic will work with organizations committed to the global human rights movement. The clinic will partner with lawyers in Africa, representing asylum seekers and refugees on their claims. USC Law students will also work on cases before international tribunals.

>>Amid the continuing legal battle over Proposition 8, the California voter-approved initiative banning same-sex marriage, nine legal scholars and gay marriage advocates met at USC Law recently to discuss marriage equality and debate how best to fight for it.

The *Southern California Review of Law and Social Justice* annual symposium "Proposition 8 and Marriage Equality," held on March 3, featured keynote speaker Shannon Price Minter, legal director of the National Center for Lesbian Rights.

Following Minter's address, two panel discussions, moderated by USC Law faculty, included panelists from USC, Lambda Legal, Love Honor Cherish, Loyola Law School and UCLA.

11) [Artistic Freedom and Artists' Rights](#)

>>Staci Riordan, chair of the Fashion Law Practice at Fox Rothschild LLP, was one of two speakers who offered USC

Law students insight into recent cases in the fashion and art worlds. The events were sponsored by the Art Law Society and the Intellectual Property and Technology Society.

Riordan provided the audience with the basics of intellectual property as it relates to fashion, and examined why the Design Piracy Prohibition Act has been introduced to Congress for a third time - legislation that would protect the overall design of a garment or other article of fashion.

In the other event, William Brutocao, speaking on his landmark case in which his client, muralist Kent Twitchell, settled his lawsuit against the U.S. government and 11 other defendants for painting over his mural in downtown Los Angeles, discussed the types of rights applicable to artists (proprietary, copyright, moral). An attorney with the Pasadena firm Sheldon Mak Rose & Anderson, Brutocao outlined the history of and reasons for the Federal Visual Artists Rights Act (VARA) and the California Artists Protection Act and how they were invoked to reach a settlement in 2008.
